- Kindergarten \$3000

Payments

- 5% Reduction for Tuition paid in full by **Thursday, July 14, 2016.**
- Monthly Tuition payments are due the first of every month.
- A LATE FEE of \$10.00 will be added to all accounts that are past due as of the 15th of each month.
- Accounts that are 45 days past due will result in dismissal of student(s) from The Carolina Academy unless balance is paid in full.
- After dismissal the account must be paid in full for student(s) to return to school or for transcripts to be released.
- All 1st semester account balances must be paid in full for student(s) to return for the 2nd semester.

I understand that my obligation to pay the fees for full academic year and any incurred penalties is unconditional and that no portion of such fees paid will be refunded nor will any outstanding balance be cancelled in the event of absence, withdrawal, or dismissal from the school of any of the above named student(s) unless the child's residence shall be removed from the area served by The Carolina Academy. **The enrollment is non-refundable.** I further understand that in signing this enrollment contract for the **2016-2017** year, I am agreeing to accept the rules and regulations of the Academy as stated in the Student Handbook and Policy Guide. I further understand that the school has the right to determine the class and work level in which the child will be assigned, to discipline or expel the child for any scholastic disciplinary reason or cause and the school shall be the sole judge of the sufficiency of such reason or cause; and to accept or not accept this applicant as a student. Furthermore, I agree to the Policy of the Academy that no grades or transcripts will be released unless the family account has been paid in full. For enrollment of all new and existing students: You must have the following documents upon enrollment.

- Birth Certificate
- Social Security card
- Immunization certificate on DHEC 2740 form (**see attached documents explaining immunization schedule for day care, which is 3K and 4K. FOR RISING 5K STUDENTS: YOU MUST HAVE ALL FOUR-YEAR OLD SHOTS FOR SCHOOL PRIOR TO ENROLLING OR FIRST DAY OF SCHOOL WITHOUT AGE-APPROPRIATE, GRADE-APPROPRIATE IMMUNIZATION.**)
- Upon enrollment, should a child require extra immunization, thirty days are granted for that immunization to be completed or said child may not come to school until fulfilled. A physician's appointment date will be required on the immunization form to carry child until date of immunization. After, proof of immunization requirement must be presented at the time of child's return to school.
