**Tuition and Fees**

- Kindergarten (3K & 4K)      \$3200
- Kindergarten 5K              \$3600
- Grades 1-5                      \$4400
- Grades 6-12                    \$4500
- **All students must meet the September 1, 2019 birthday deadline for the kindergarten class they are entering for the 2019-2020 year.**
- 12.5% Tuition Reduction for 2<sup>nd</sup> and 3<sup>rd</sup> child.
- No Tuition Reduction for 1<sup>st</sup> child.
- No Tuition for 4<sup>th</sup> child or more.
- **\$100 Enrollment Fee per family through March 19, 2019**
- Enrollment Fee **will increase** to **\$200** per family on **March 20, 2019**
- **\$100 All-In fee per child through Tuesday, March 19, 2019**
- All-In fee **will increase** to **\$200** per child on **Wednesday, March 20, 2019**
- **Tuition payments** may be financed over 10 or 12 months.  
     **10 month** payments- start in **August and end in May.**  
     **12 month** payments- start in **June and end in May.**
- **ALL PAST DUE ACCOUNTS: MUST BE CURRENT IN ORDER TO ENROLL FOR NEXT SCHOOL YEAR. NO EXCEPTIONS.**
- **ENROLLMENT AND ALL-IN FEES MUST BE PAID IN ADVANCE.**  
     NO FINANCING.

**Payments**

- 5% Reduction for Tuition paid in full by **Thursday, July 11, 2019.**
- Monthly Tuition payments are **due the first** of every month.
- A LATE FEE of \$10.00 will be added to all accounts that are past due as of the 15<sup>th</sup> of each month.
- Accounts that are **45 days past due** will result in dismissal of student(s) from The Carolina Academy unless balance is paid in full.
- After dismissal, the account **must be paid in full** for student(s) to return to school or for transcripts to be released.
- **All 1<sup>st</sup> semester account balances must be paid in full for student(s) to return for the 2<sup>nd</sup> semester.**

Furthermore, I agree to the Policy of the Academy that no grades or transcripts will be released unless the family account has been paid in full.
