Tuition and Fees

- Kindergarten (3K & 4K) \$3200
- Kindergarten 5K \$3600
- Grades 1-5 \$4400
- Grades 6-12 \$4500
- All students must meet the September 1, 2021 birthday deadline for the kindergarten class they are entering for the 2021-2022 year.
- 12.5% Tuition Reduction for 2nd and 3rd child.
- No Tuition Reduction for 1st child.
- No Tuition for 4th child or more.
- **\$100 Enrollment Fee per family through March 12, 2021**
- Enrollment Fee will increase to **\$200** per family on **March 12, 2021**
- **\$100 All-In fee per child through March 21, 2021**
- All-In fee will increase to **\$200** per child after **March 12, 2021**
- **Tuition payments** may be financed over 10 or 12 months.
 10 month payments- start in August 1st and ends May 1st 2022.
- **12 month payments-** start in June 1st and ends May 1st 2022.
- **ALL PAST DUE ACCOUNTS: MUST BE CURRENT** IN ORDER TO **ENROLL** FOR NEXT SCHOOL YEAR. **NO EXCEPTIONS.**
- **ENROLLMENT AND ALL-IN FEES MUST BE PAID IN ADVANCE.**

Payments

- 5% Reduction for Tuition paid in full by **Thursday, July 15, 2021.**
- Monthly Tuition payments are **due the first** of every month.
- A LATE FEE of \$10.00 will be added to all accounts that are past due as of the 15th of each month.
- Accounts that are **45 days past due** will result in dismissal of student(s) from The Carolina Academy unless balance is paid in full.
- After dismissal, the account must be paid in full for student(s) to return to school or for transcripts to be released.
- **All 1st semester account balances must be paid in full for student(s) to return for the 2nd semester.**

I further understand that the school has the right to determine the class and work level in which the child will be assigned, to discipline or expel the child for any scholastic disciplinary reason or cause and the school shall be the sole judge of the sufficiency of such reason or cause; and to accept or not accept this applicant as a student. Furthermore, I agree to the Policy of the Academy that no grades or transcripts will be released unless the family account has been paid in full.
