## **Payments**

- 5% Reduction for Tuition paid in full by Thursday, July 13, 2023
- All Tuition payments are due based on tuition plan in FACTS.
- LATE FEE will be applied per terms of payment plan.
- Accounts that are <u>45 days past due</u> will result in <u>dismissal</u> of student(s) from The Carolina Academy unless balance is paid in full.
- After dismissal, the account <u>must be paid in full</u> for student(s) to return to school or for transcripts to be released.
- All 1<sup>st</sup> semester account balances must be paid in full for student(s) to return for the 2<sup>nd</sup> semester.

I understand that my obligation to pay the fees for full academic year and any incurred penalties is unconditional and that no portion of such fees paid will be refunded nor will any outstanding balance be cancelled in the event of absence, withdrawal, or dismissal from the school of any of the above named student(s) unless the child's residence shall be removed from the area served by The Carolina Academy. <u>The enrollment and All-In</u> fees are non-refundable.
